- 1. The Government of Uganda represented by Ministry of Defence and Veterans Affairs [MoD&VA] has allocated funds to be used for the acquisition of PVC MAT/Ground Sheet under Framework Contract Arrangement.**
- 2. The Ministry of Defence and Veterans Affairs [MoD&VA] invites sealed bids from eligible bidders for the provision of PVC MAT/Ground Sheet under Framework Contract Arrangements.**
- 3. Bidding will be conducted in accordance with the Open Domestic Bidding method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders.**
- 4. Interested eligible bidders may obtain further information and inspect the bidding documents at the address given below at 8(a) from 10th July 2017 to 8th August, 2017 from 08:00 am to 01:00 pm and 02:00 pm – 04:30 pm.**

The Bidding documents in English may be purchased by interested bidders on the submission of a written application to the address below at 8(a) and upon payment of a non-refundable fee of Uganda Shillings One Hundred Thousand only (UGX. 100,000). The method of payment will be by Bank payment advice forms picked by bidders or their representative and obtaining a General Receipt from the MoD Cashier. The document will be picked by the bidder's authorised representative. No liability will be accepted for loss or late delivery.**
- 6. Bids must be delivered to the address below at 8(a) on or before 8th August, 2017 at 02:10 pm. All bids must be accompanied by a bid security of Uganda Shillings 10,000,000. Bid securities or bid securing declarations must be valid until 8th February 2018. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(a) on 8th August, 2017 at 02:30 pm.**
