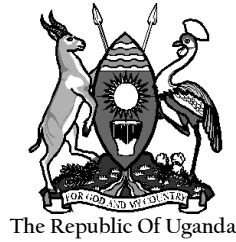

BID NOTICE UNDER OPEN BIDDING

23rd October, 2017

Invitation to bid for Procurement of Plastic Water Tanks

1. The Ministry of Defence and Veteran Affairs has allocated funds to be used for the acquisition of Plastic *Water Tanks*
2. The Entity invites sealed bids from eligible bidders for the provision of the above supplies.
3. Bidding will be conducted in accordance with the *Open Domestic Bidding Method* contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders.
4. Interested eligible bidders may obtain further information and inspect the bidding documents at the address given below at 8(a) from **8:30am -4:30pm during Working days.**
 1. The Bidding documents in English may be purchased by interested bidders on the submission of a written application to the address below at 8(b) and upon payment of a non-refundable fee **of UGX. 100,000/= [i.e. Uganda shillings One hundred thousand only]**. The method of payment will be by **Bank payment advice forms picked by bidders or their representative and obtaining a General Receipt from the MoD Cashier.** The document will be picked by the bidder's authorised representative. No liability will be accepted for loss or late delivery.
5. Bids must be delivered to the address below at 8(c) at or before **2:00pm on 17th November, 2017.** All bids must be accompanied by a bid security of UGX 3,570,000/=. Bid must be valid until **11th June, 2018.** Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(d) at **02:10 pm on 17th November, 2017**
